#### **What is the purpose of this update?**

This document tells you how the Global Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. IOOF New Zealand Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

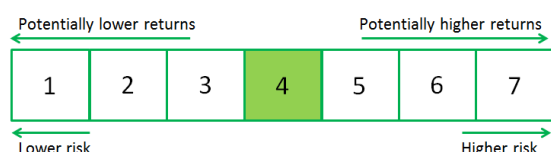
The fund invests in international shares through investment funds operated by our Investment Manager, with a small allocation to cash for operational liquidity. It aims to achieve long-term capital growth through a structured exposure to listed global shares. Investors are exposed to developed and developing economies through an efficient exposure to a highly diversified pool of assets, using both qualitative and quantitative investment techniques.

The Fund is unhedged, and volatility is expected to be medium to high.

#### **What are the risks of investing?**

Risk indicator for Global Equities Fund

relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

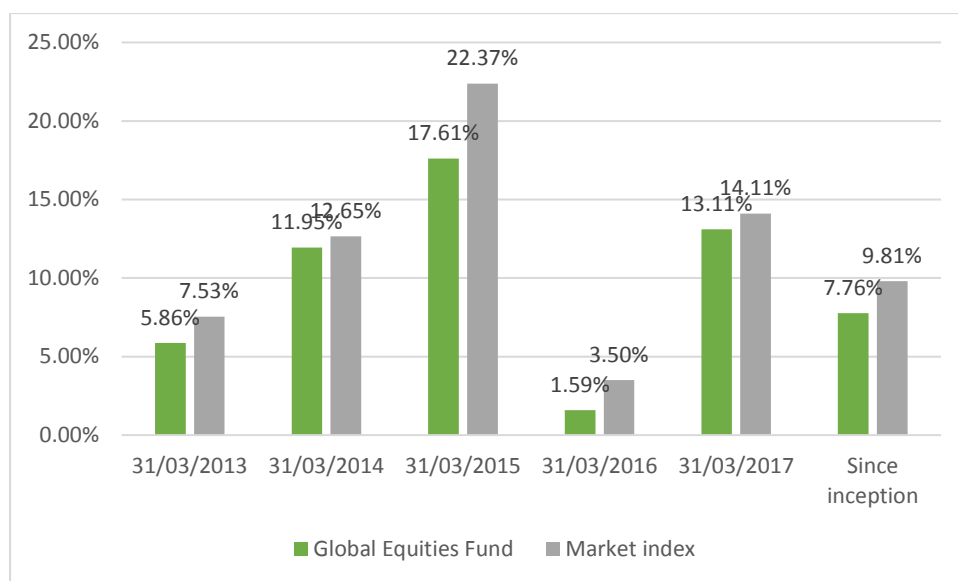

### Example of how this applies to an investor

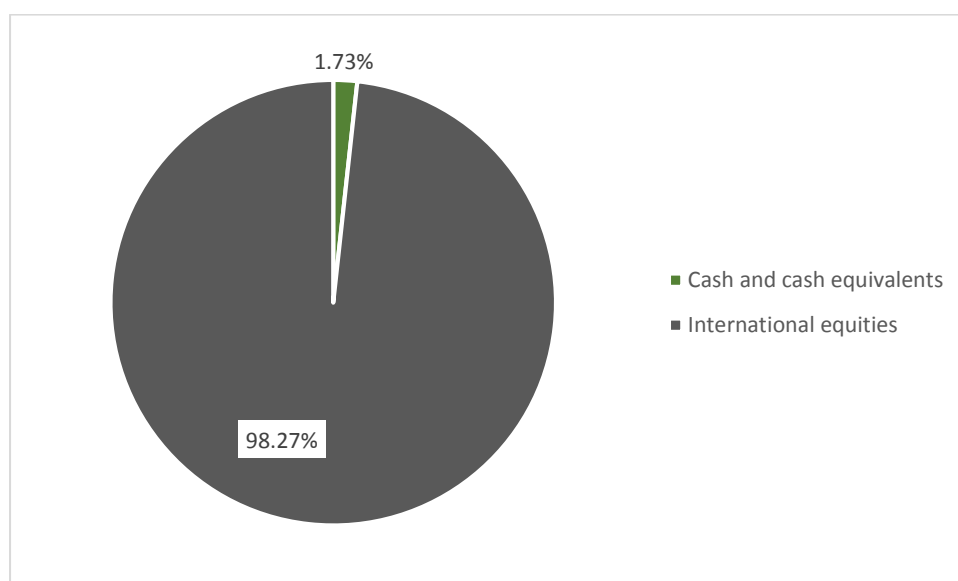
Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$1,311 (that is 13.11% of his initial \$10,000). Chris did not pay any other charges. This gives Chris a total return after tax of \$1,311 for the year.

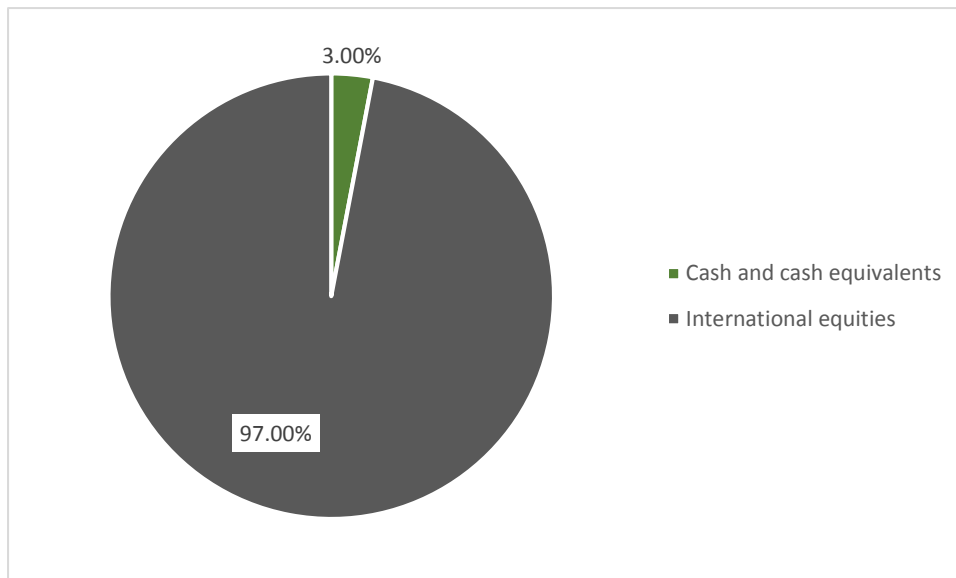

## Notes

Note 1: The Manager's basic fee is a variable percentage up to 0.65%, and is charged to the investor rather than the Fund. The Manager's basic fee disclosed in the Fund Update is an estimate because it represents an allocation of the total actual amount paid by Scheme investors for this period. The Other management and administration fee includes an estimate of the fees for investment into the underlying fund and is based on management fee rates disclosed by that underlying fund managers.
