I/We understand that if my/our switch request is received by the Manager prior to noon (NZ time), if possible the redemption transaction ('switch from') will be processed at the redemption (sell) price applicable for the day it is received, but if it is received after this time it will be processed at the next day's redemption (sell) price. The application transaction ('switch to') will be processed at a different day's issue price based on the availability of the redemption proceeds.

I/We understand that I/we will not be charged a fee to switch investments, but that transaction costs will be incurred because in determining the Unit prices of the funds, a buy/sell spread is incurred each time units are redeemed or applied for. This additional cost to the investor is an allowance made for brokerage, underlying manager spreads and other transaction costs associated with buying and selling the underlying investments of the funds.
